- Step-By-Step, Inc. and the Hot Lips Barbecue Cookoff Committee have the rights to modify or expand these rules and regulations.
- Entry fee of \$150 includes team entry for one up to three of the BBQ categories.
- Entry forms are due to Chair John F. Scott no later than Thursday September 6<sup>th</sup>, 2018. Fees, however, can be paid on-site when the cooks arrive, but must be paid before judging begins.
- BCA Rules and Regulations will be followed for cooking and judging. Rules can be found at [www.bcabbq.org](http://www.bcabbq.org).
- Decisions of the Hot Lips Barbecue Cookoff Committee and BCA judging are final.
- Step-By-Step, Inc. and the Hot Lips Barbecue Cookoff are not responsible for theft or damage to equipment or property of the contestants.
- The Head Cook of each team will be held responsible for the conduct of its members or any persons who are or have been in his/her cook space.
- Each Head Cook will be given space to prepare entries. Generators will be allowed.
- Teams must provide their own meat products.
- Holes or dug pits are not permitted.
- Heat shields must be provided for cookers capable of damaging property surrounding the cookers.
- No open flames of any kind will be permitted except inside the cookers (e.g. no tiki torches or campfires will be allowed.)
- Each team must bring a working fire extinguisher.
- Teams must supply all needed equipment and supplies. Step-By-Step, Inc. and the Hot Lips Barbecue Cookoff will provide setup/cooking space, limited electricity, and limited water.
